I. Welcome/Updates/Intra-System Communication

All members present introduced themselves, some provided updates:

- Trevor Walraven spoke about SB 1008 and that youth charged with violent crimes will be tried in youth court instead of adult court, regardless of charge. Youth 15 – 17 will require a waiver process to be sent to adult court, as has been the case for those under 15. OYA will parole youth who are not Measure 11.
- Lisa Roth reported that Trillium Behavioral Health will be returning to its former name of LaneCare, due to the fact that the new CCO is now compiled of both Trillium and PacificSource. There should not be an impact to services, although there may be some instances where a parent and child may be on separate plans. More information on the process and how to choose between plans will be available in the coming months.
- Jason Jones reported that the OYA budget is great. They are still trying to limit parole revocation. They cannot go longer than six months unless two criteria are met. There are a couple of facilities which have yet to undergo training.
- Nathaline shared that DYS has recently made a “Pod Plus” next to the detention pod which will be used for alternate activity space to incentivize youth. It will also provide a space to remove an audience during de-escalation.
DYS continues to let law enforcement know that we can’t detain youth under 12 years of age unless there is a review by a judge and a written court order. We also can’t have the youth waiting around here while this paperwork is being processed. We will continue to educate on detainable vs. non-detainable.
DYS is expanding access to services at Phoenix.
The detention pod was painted for the first time in 20 years.

III. Presentation by Eugene School District 4J – Kari Skinner

Kari Skinner the attached handout regarding School Threat Assessments. There will be a Salem-Keizer School Threat Assessment training at Whitaker, 200 N. Monroe, in the auditorium, on October 3rd and 4th for community partners.

Discussed the staffing of a kiddo who had been under the radar. Father was doctor and mother stayed at home with the kids. However, father was gone a lot and mom was overwhelmed. Youth began acting out sexually. The issues came to light when the police located the missing phone of his teacher in his possession and found that he had been using it to view pornography. Community partners came together to provide resources and support. The partners had each had small pieces of the puzzle and together they were able to create the whole picture and make a plan.

IV. Discussion by DYS Supervision – Gustavo Presidente

Gustavo Presidente discussed the Problematic Sexual Behavior (PSB) process and the Disposition and Case Management Matrixes (DCM) which are used with all youth to provide consistent case management standards that reflect the risk level of the youth and the severity of the referral. The matrix provides a guide to provide the most effective resources.

Kari Skinner shared that Salem-Keizer Education Center will be offering training on the topic for \$245 and provided a flyer (attached) for the committee.

V. Discussion by DYS Restorative Services – Jane Backen

Jane Backen discussed the Juvenile Crime Prevention plan assessment used to assess risk factors and identify needed resources for youth. Assessments are done with each police referral and redone when there is a new referral or at six months. Restorative Services has recently begun providing these assessments to youth in diversion who wouldn't have received assessments in the past.

The State of Oregon recently identified the usefulness of these assessments in tracking and reporting on recidivism, which led to the implementation in Restorative Services diversion cases.
